- 1) To consider amending **Chapter 92-2 “Night Parking by commercial vehicles”** of the Hempstead Village Code
- 2) Presentation of activities report by the public bodies of the Incorporated Village of Hempstead.
- 3) Authorization for the reading of the minutes of the **Regular Meeting August 3 2022, and the Special Meeting of August 16,2022**, be dispensed with and that they be accepted as reviewed.
- 4) Mayor Hobbs and Deputy Mayor Daniels approve miscellaneous license and permit applications as reviewed.
- 5) Report of the Village Justice for the month of **July 2022**.
- 6) Authorization by the Board to approve the Incorporated Village of Hempstead to enter into an agreement with **Accudata Workforce Solutions**, 95 W. Old Country Road, Hicksville, NY to provide payroll processing, time and attendance systems.
- 7) Authorization by the Board to approve the Incorporated Village of Hempstead to enter into an agreement with **All City Management Services, Inc.**, to provide crossing guard services to the Village of Hempstead at a rate of **\$28.32** per hour per crossing guard and pursuant to the terms of the contract herein, from **July 1, 2022 to June 30, 2023**.
